
INFRA'AGING™: A BREAKTHROUGH APPROACH OF PHOTOAGING

For many years, sun-induced aging, also called photoaging, was attributed only to ultraviolet rays (UV), but infrared (IR) rays and the heat they generate also largely contribute to the loss of skin firmness and elasticity leading to the appearance of premature wrinkles. Lucas Meyer Cosmetics named this novel concept Infra'Aging™ (IR-induced aging), this concept also underlines thermal aging (heat-induced aging) which greatly worsens skin aging.

Underestimated for years, Infra'Aging™ fight is a breakthrough and existing challenge to complement efficacy of sun protective products.

PROTECTING DERMIS FIBER INTEGRITY

UV and IR penetrate dermis with a different depth but both affect the quality of elastic fibers. Cathepsin G is an enzyme highly present in photoaged skin and has for consequence of inducing an increase of MMP synthesis responsible for dermis fiber degradation. By inhibiting Cathepsin G activity, $Elix-IR^{TM}$ protects tropoelastin and fibrillin-1, the main components of the elastic fibers distributed in papillary dermis (upper dermis) and in reticular dermis (lower dermis).




PRESERVING SKIN FIRMNESS & ELASTICITY

Test protocol

- 20 women regularly exposed to sun (age between 35 to 65 years);
- Twice daily application of a cream with 2% Elix-IR™ on forearm versus a placebo during 28 days (no sunscreen used);
- Test done during high summer season = high sun exposure;
- Skin firmness and elasticity measurements with a Cutometer® at DO and D28.





REDUCING THE APPEARANCE OF WRINKLES

Test protocol

- 20 women regularly exposed to sun (age between 35 to 65 years);
- Twice daily application of a cream with 2% Elix-IR™ on split-face versus a placebo during 28 days (no sunscreen used);
- Test done during high summer season = high sun exposure;
- Crow's feet wrinkle measurements with dermaTOP-blue (*in vivo* 3D scanner) at D0 and D28.
